This Information Memorandum is prepared by the Spectrum Management Authority (the Authority), after consultation with the Office of Utilities Regulations (OUR) and the Fair Trading Commission (FTC), with the aim of provisioning mobile broadband services in the 614-698 MHz band in compliance with the 3GPP band plan 71/71N and bears reference number, SMA-IM-600-2024-08-26.

The publication of this Information Memorandum for the assignment of spectrum in the 614-698 MHz band, follows the natural end of the process identified with reference number SMA-IM-600-2024-05-29 and as defined in the Authority's Information Memorandum, dated the 29th of May 2024, due to the applicants not meeting the pre-qualification requirements.

This Information Memorandum is made available on the express understanding that it will be used for the sole purpose of assisting the recipient of this Information Memorandum in deciding whether it wishes to proceed with a further investigation of possible participation in the process. This Information Memorandum is not intended to form any part of or influence any investment decision or other evaluation or any decision to participate in the public call for applications and should not be considered as a recommendation by the Authority or its advisers to any recipient of this Information Memorandum to participate in the public call for applications. Each recipient of this Information Memorandum must make its own independent assessment of the potential value of the licence after making such investigation as it may deem necessary to determine whether to participate in the public call for applications.

3 BACKGROUND AND OBJECTIVE OF THE PUBLIC CALL FOR APPLICATION

As the global market for mobile broadband services is continuously growing, mobile network operators are seeking access to more spectrum. In Jamaica mobile broadband services are also expected to grow significantly because mobile users on legacy networks will migrate to 4G/LTE and 5G networks. Hence network traffic will increase significantly, in turn increasing the demand for spectrum.

The allocation and assignment of spectrum for mobile broadband services supports the objectives as defined in Jamaica's National Development Plan, Vision 2030 Jamaica. This national plan aims to expand the broadband networks island-wide, as well as increase access to internet connectivity on an affordable basis to help bridge Jamaica's internal digital divide.

After conducting an extensive industry consultation in 2022, the Authority repurposed the 614-698 MHz band which was previously allocated to broadcasting services. Subsequently, the service allocations for the 614-698 MHz band, as included in the National Frequency Allocation Table (NFAT), have been changed from the primary service allocations for broadcasting, mobile and fixed services to a primary service allocation for mobile services and a secondary service allocation for fixed services. Hence, the primary service allocation for broadcasting service is no longer included in the NFAT for this part of the spectrum.

In further support of this band repurposing effort, the Authority had the 614-698 MHz identified for International Mobile Telecommunications (IMT), which is the technical reference for mobile broadband services, in the International Telecommunication Union (ITU) Radio Regulations, at the World Radiocommunications Conference 2023 (WRC-23), held during 2023 November 20 to 2023 December 15.

The publication of this Information Memorandum for the assignment of spectrum in the 614-698 MHz band, follows the natural end of the process with reference number SMA-IM-600-2024-05-29 and as defined in the Authority's Information Memorandum, dated the 29th of May 2024, due to the applicants not meeting the pre-qualification requirements.

Considering the above, the Authority is initiating this public call for application procedure, as set out in this Information Memorandum, with the objective of assigning spectrum in the 614-698 MHz band for mobile broadband services. The Authority wishes to indicate however that the spectrum range which is the subject of this call for applications is currently occupied and as such, the awardee(s) will only be granted a licence once the band is officially cleared.

4 AVAILABLE SPECTRUM AND SPECTRUM ON OFFER

In the following two sections, the available spectrum for mobile services and the spectrum on offer in this public call for application are described.

4.1 AVAILABLE SPECTRUM FOR MOBILE SERVICES

A spectrum analysis was conducted to identify the available spectrum for mobile services. For this spectrum analysis the following activities were carried out:

- Review of the National Frequency Allocation Table (NFAT), with special attention to the Jamaican footnotes and Jamaican deviations from the allocations as included in the ITU Radio Regulations, Article 5 (ITU-RR);
- 2. Identification of the IMT identifications in the ITU-RR for Region 2 and all Regions, and those relevant for Jamaica;
- 3. Identification of the 3GPP band plans for the spectrum bands 600, 700, 850, 900, 1900, 1700/2100, 2600 and 3500 MHz;
- 4. Retrieval of spectrum assignment data from the SMA's automated spectrum management system;
- 5. Identification of available bandwidth in the 3GPP band plans *in use* in Jamaica by applying the following key spectrum compatibility and priority rules:
 - For overlapping band plans in use in Jamaica, the overlapping spectrum not assigned in either band, is deemed to be available in the band plan with most MNOs (and hence not available in the other band plan with less MNOs);
 - b. Available bandwidth of band plans in use but overlapping with assignments in other coprimary allocations is not considered available;
 - c. Available bandwidth of band plans in use but overlapping with the ISM allocation in the Jamaican NFAT is not considered available;
- 6. Identification of available bandwidth in the 3GPP band plans **not in use** in Jamaica by applying the following key spectrum compatibility and priority rules¹:
 - a. Band plans not in use have a lower priority than band plans in use, resulting in that overlapping spectrum in either the up- or downlink of the band plan not in use, is not considered available;
 - b. Band plans not in use and reserved for Government use (14/14N), are not considered available;
 - c. Available bandwidth of band plans not in use but overlapping with assignments in other co-primary allocations is not considered available;
 - d. Available bandwidth of band plans not in use but overlapping with the ISM allocation in the Jamaican NFAT is not considered available.

¹ Only 3GPP band plans that have a recorded implementation elsewhere in the world are considered. Band plans without any implementation elsewhere in the world are not considered, as the availability and affordability of equipment will be problematic for Jamaica.

Table 3 shows the results of the spectrum analysis for the band plans in use in Jamaica, with the last column listing the total available bandwidth per band plan (h), which is defined as: assigned in band plan (b) + available bandwidth left in band plan (g).

4.2 SPECTRUM ON OFFER IN THE PUBLIC CALL FOR APPLICATION

Two spectrum lots are on offer in this public call for applications. In accordance with 3GPP band plan 71/71N, the spectrum lots are defined as follows:

- 1. Contiguous 2x20 MHz in the band 617-652 MHz (downlink) and 663-698 MHz (uplink);
- 2. Contiguous 2x15 MHz in the band 617-652 MHz (downlink) and 663-698 MHz (uplink).

The terms and conditions for the use of these spectrum lots are included in section 5.

5 TERMS AND CONDITIONS OF THE SPECTRUM LICENCE

This section provides an overview of the terms and conditions of the Spectrum Licence.

5.1 RIGHTS CONFERRED BY THE SPECTRUM LICENCE

The Spectrum Licence gives the Licensee the right to use the spectrum to offer mobile broadband services to the public in Jamaica via radio transmitting and receiving stations and/or radio apparatus, subject to the terms and conditions of the Spectrum Licence. The Spectrum Licence will not mandate a specific technology to be used.

The Spectrum Licence is a secondary licence to the required telecommunications carrier and service provider licences issued by the responsible Minister pursuant to section 13 of the Telecommunications Act and can only be awarded to a company which holds these necessary valid licences.

5.2 TECHNICAL NETWORK IMPLEMENTATION STANDARD

The technical network implementation needs to comply with the 3GPP Release for Cellular Mobile LTE, TS 23.401 latest version (currently 18.15.0 March 2024), *General Packet Radio Service (GPRS) enhancements for Evolved Universal Terrestrial Radio Access Network (E-UTRAN) access.* Applicants need to indicate what parts (or functionality) of the technical standard will be implemented.

5.3 MINIMUM SERVICE LEVELS

The following minimum service levels are stipulated:

5.3.1 Minimum network coverage

The Licensee is to utilise the assigned 600 MHz spectrum for the deployment of commercial mobile broadband services as follows:

- 1. At least 50% population coverage in the entire country within 12 months from the start date of the validity of the Licence;
- 2. At least 95% population coverage in the entire country within 24 months from the start date of the validity of the Licence.

In addition, the Licensee is to utilise the assigned 600 MHz spectrum for the deployment of commercial mobile broadband services within the unserved or underserved communities as detailed in Appendix D: List of Unserved and Underserved Communities, as follows:

- 1. At least 50% of the population in the unserved or underserved communities within 12 months from the start of the validity of the Licence;
- 2. At least 95% of the population in the unserved or underserved communities within 24 months from the start of the validity of the Licence.

5.3.2 Minimum data rate

The Licensee is to provide a minimum download data rate of five (5) Mbps under peak traffic conditions in any of the coverage areas as stipulated in section 5.3.1.

5.4 SPECTRUM USE

The mobile broadband services, as described in this Information Memorandum, are to be provided for nomadic, slow and high mobility use cases. This requires the deployment of a mobile-cellular network. This mobile-cellular network and the assigned spectrum should be deployed nationwide. The spectrum is explicitly not to be used for Fixed Wireless Access (FWA) applications.

The spectrum lot, as included in section 4.2, can be used when the associated Spectrum Licence is granted by the Minister. The Minister will grant the Spectrum Licence after the exit plan of the incumbent spectrum user has been approved and the 614-662 MHz has been cleared.

5.5 HARMFUL INTERFERENCE

Pursuant to Section 63A(1) of the Telecommunications Act, the Licensee will comply with any request or directive issued by the Minister or the Authority to ensure that the activities of the Licensee do not cause harmful interference to the lawful operation of any other licensed or authorised spectrum user.

5.6 LICENCE DURATION

The duration of the Spectrum Licence shall be fifteen (15) years and is renewable subject to the Spectrum Licensee's compliance with the terms and conditions of the Spectrum Licence and in accordance with the provisions of the Telecommunications Act. The Spectrum Licensee will be expected to use the spectrum in an efficient manner. The Spectrum Licence is neither assignable nor transferrable in whole or in part.

At the end of the initial term (15 years), the Minister, in consultation with the Authority, shall determine the parameters for renewal and determine the applicable fees to be paid by the Licensee to facilitate the renewal of the Spectrum License for another period.

5.7 FEES PAYABLE

The Spectrum Licensee, which is to be determined through this public call for application, is required to pay Spectrum License Fees for utilizing the assigned spectrum, as defined in section 6.3 Application Data Sheet for the initial term of fifteen (15) years. The payment schedule for these Spectrum License Fees comprises the Deposit and the remaining portion to be paid in accordance with the schedule as set in this Information Memorandum.

The (Spectrum) Licensee shall each pay annual Spectrum Regulatory Fees as invoiced, to cover the reasonable operating costs of the Authority. The amount of the Spectrum Regulatory Fee shall be calculated based on The Telecommunications (Spectrum Regulatory Fees) (Amendment) Regulations, 2017.

At the end of the Initial Term (15 years), the Minister, in consultation with the SMA, shall determine the parameters for renewal and determine the applicable fees to be paid by the Licensee to facilitate the renewal of the Spectrum License for such period or periods as may be determined.

5.8 TERM, REVOCATION AND SUSPENSION

The duration of the Spectrum Licence shall be fifteen (15) years and is renewable subject to the Licensee's compliance with the terms and conditions of the Spectrum Licence and accordance with the provisions of

the Telecommunications Act, 2000 as amended. The Licensee will be expected to use the spectrum in an efficient manner. The Spectrum License is not saleable or divisible in whole or in part.

The Spectrum Licence may be suspended or revoked in accordance with section 23A of the Telecommunications Act.

5.9 RADIO EQUIPMENT TECHNICAL CONDITIONS

The Spectrum Licence will contain the minimum necessary restrictions on the permitted use of the spectrum to manage the risk of harmful interference and to ensure compliance with the Authority's duties as the manager of the spectrum. Licensees will be required to submit technical details for proposed radio communication equipment to the Authority for review and approval, including type approval certification. A schedule of technical information will be prepared and appended to the Spectrum Licence awarded.

5.10 ACCESS AND INSPECTION

The Spectrum Licensee will be required to permit persons authorized by the Authority, that is, staff or authorized agents, to have access to and to examine and test the radio equipment specified in the Spectrum Licence at all reasonable times. The purpose would be to ensure that the radio equipment is being used in accordance with the conditions of the Spectrum Licence.

5.11 MODIFICATION, RESTRICTION AND CLOSEDOWN

The Authority shall require the radio equipment in use or any part of it to be modified, restricted, or temporarily or permanently closed down if:

- 1. The Spectrum Licensee has breached the terms of its licence, and/or;
- 2. The use of the radio equipment is or may be causing or contributing to interference with the operation of other licensed or authorized spectrum users.

6 CALL FOR APPLICATION GUIDELINES & REQUIREMENTS

This section includes application guidelines and the applicant requirements.

6.1 CALL FOR APPLICATION GUIDELINES & REQUIREMENTS

The application procedure comprises four consecutive stages:

- 1. Application Invitation Stage;
- 2. Application Pre-qualification Stage;
- 3. Application Evaluation Stage; and
- 4. Licence Assignment Stage.

6.1.1 Application Invitation Stage

The Application Invitation Stage commences on the date that the Authority makes this Information Memorandum available for potential Applicants, and ends at the date and time specified in section 6.3 Application Data Sheet when Applicants are required to have submitted their Application to the Authority.

The Application constitutes all the documentation that the Applicant has submitted to the Authority in response to this Information Memorandum on or before the deadline specified for application submission in section 6.3 Application Data Sheet. Table 5 lists all the documents that the Applicant must submit to the Authority by the said deadline.

Respondents to this Information Memorandum will be deemed to have consented to the disclosure of confidential information to all persons legitimately engaged in the processing and evaluation of the public application and the spectrum licensing process.

The Application Pre-qualification Stage is the stage of the public call for applications procedure in which the Authority will assess if the submitted Applications meet the Application Pre-qualification Criteria. The Application Pre-qualification Stage commences and terminates on the dates as indicated in section 6.3 Application Data Sheet.

6.1.2.1 Application pre-qualification documents and criteria

In the Application Pre-qualification Stage, the application pre-qualification documents, as listed in Table 5, will be used by the Authority to assess whether the Applicant has met the Application Pre-qualification Criteria, outlined in Table 6 below.

6.1.3 Application Evaluation Stage

The Application Evaluation Stage is the stage of the public call for applications procedure in which the Evaluation Committee will evaluate each of the Applications of the Qualified Applicants and allocate scores in accordance with the Application Evaluation Criteria outlined in Table 8 below. The Application Evaluation Stage commences and terminates on the dates as indicated in section 6.3 Application Data Sheet.

6.1.3.1 Application evaluation documents and criteria

In the Application Evaluation Stage, the application documents, as listed in Table 7 below, and as included in the Application of the Qualified Applicants, will be evaluated by the Evaluation Committee.

The Evaluation Committee will be staffed by representatives of the Authority with competencies to include, *inter alia*, legal, technical and financial competencies.

The Evaluation Committee will analyse the application documents set out in Table 7 above and determine for each Application the score based on the Application Evaluation Criteria as included in Table 8 below.

An Application shall be rejected at the Application Evaluation Stage if it does not respond to the Application Evaluation Criteria or if it fails to achieve the minimal score as indicated in section 6.3 Application Data Sheet.

The accepted Applications will be ranked by the Evaluation Committee from the highest to the lowest score.

Prior to confirming the Awardee(s), the Authority will determine whether the Applicant's total spectrum holdings, including the spectrum holding in the 614-698 MHz band on offer in this public call for applications, are not above 33% of the available spectrum for MNOs, as totalled in the last columns of Table 3 and Table 4. If applicable, in checking the Applicant's total spectrum holdings, the Authority will consider the amount of spectrum (in MHz) the Applicant has offered to relinquish. It should be noted that consideration for the relinquishing of spectrum will only be given to low-band spectrum (i.e. 700, 850 and 900 MHz). If applicable, the Applicant has to specify the low-band spectrum that will be relinquished in Form 5: Application Submission Form, detailing the frequencies and bandwidth (in MHz) that will be relinquished for each spectrum licence the Applicant holds. Any low-band spectrum to be relinquished which are not clearly defined in Form 5: Application Submission Form, cannot be considered for the relinquishing of spectrum.

In the event that the Applicant's total spectrum holdings are above 33% of the available spectrum for MNOs, the Applicant cannot be confirmed as an Awardee and the Application will be rejected. If the Application is rejected the Authority will proceed to and do a similar assessment of the spectrum holdings of the next highest Application to ascertain whether that Applicant can be confirmed as an Awardee.

6.1.3.3 Most recent duly audited financial statements

The Applicant must submit its audited financial statements for the three most recent financial years. This audited annual report should comply with the Generally Accepted Accounting Principles (GAAP), as applied in the Jamaican jurisdiction, and should include an audit report and opinion.

6.1.4 Licence Assignment Stage

The Licence Assignment Stage is the stage of the public application procedure in which the Minister grants the Spectrum Licence, upon the recommendation of the Authority. The confirmed Awardee(s) will enter the Licence Assignment Stage in order of the highest to the lowest score on the Application Evaluation Criteria².

For a confirmed Awardee that has entered the Licence Assignment Stage and provided a Deposit by way of an Irrevocable letter of Undertaking, the Deposit will be immediately demanded in accordance with the procedure included in section 6.3 Application Data Sheet.

Before the Authority makes a recommendation to the Minister regarding who should be the Awardee(s) to be granted a Spectrum Licence, the following conditions shall be met:

1. A confirmed Awardee will be required to undertake in writing to the Authority that the confirmed Awardee accepts that the submitted Business Plan will be attached as an annex to the Spectrum Licence and that this Business Plan will form an integral part of the Spectrum Licence terms and

² In the event of two (or more) confirmed Awardees having an equal score on the Application Evaluation Criteria, the confirmed Awardee with the lowest amount of current spectrum holdings (in MHz) in the sub 1 GHz band, will enter the Licence Assignment Stage first.

- conditions, particularly sections relating to the projections made on the network deployment, its maintenance, the offered service levels, the customer care, protection and commercial offerings;
- A confirmed Awardee must commit, by an irrevocable letter of undertaking, to pay the
 outstanding balance for the Spectrum Licence Fee in ten (10) equal instalments over the first ten
 (10) years of their licence. This payment will commence one year after the start date of the validity
 of the Licence as stated in the Spectrum Licence. A confirmed Awardee will be informed of the
 payment dates by the Authority;
- 3. The Authority will revoke the amount of spectrum a confirmed Awardee has offered to relinquish and adjust the spectrum licences, considering a timeline to be agreed for terminating the use of the spectrum to be relinquished.

In the event that the above listed conditions are:

- 1. Met, the Authority will recommend the Minster to grant a Spectrum Licence for the spectrum lot that was indicated in the Application of a confirmed Awardee, as long as enough spectrum is available in band plan 71/71N. In case not enough spectrum is available in band plan 71/71N to grant the spectrum lot that was indicated in the Application of a confirmed Awardee, the Authority will offer a confirmed Awardee the remaining spectrum in band plan 71/71N, being 2x15 MHz, for their acceptance. If the remaining spectrum is accepted by a confirmed Awardee, the Authority will recommend the Minister to grant a Spectrum Licence for the remaining spectrum in band plan 71/71N;
- 2. Not met, a confirmed Awardee cannot be recommended to the Minister to be granted a Spectrum Licence and the Application will be rejected.

After a confirmed Awardee is either recommended or not recommended to the Minister to be granted a Spectrum Licence, the next highest confirmed Awardee will enter the Licence Assignment Stage.

By public notice the Authority will announce the confirmed Awardee(s) that are recommended to the Minister to be granted a Spectrum Licence(s) and will inform all Applicants in writing of the outcome of the public application.

In accordance with the procedure included in section 6.3 Application Data Sheet, the Deposit will be released as follows:

- 1. For any Applicant, not recommended to the Minister for licensing, the full amount of the Deposit will be released;
- 2. For an Applicant, recommended to the Minister for licensing but for a smaller amount of spectrum that was indicated in their Application, i.e. the remaining spectrum in band plan 71/71N, an amount will be released as indicted in section 6.3 Application Data Sheet.

6.2 INSTRUCTIONS TO THE APPLICANTS

The Applicant is required to submit all documents as defined in Table 5 in section 6.1.1.

The stated documents should be contained in one correctly labelled sealed envelope and be deposited within a designated application box located at the Authority's office.

6.2.1 Preparation of Applications

Applicants are expected to carefully examine all instructions, forms, terms, and specifications in the Information Memorandum. Failure to furnish all mandatory information or documentation required by the Information Memorandum shall result in the rejection of the Application.

6.2.2 Cost of preparation of Applications

Applicants shall bear all costs associated with the preparation and submission of its Application, and the Authority shall not be responsible or liable for those costs.

The Authority shall incur no liability by virtue of it exercising its right to cancel the application procedure prior to the licensing of the Awardee or where an Applicant is otherwise disqualified.

6.2.3 Language

Applications, as well as all correspondence and documents relating to the Application exchanged by the Applicant and the Authority, shall be written in the English language.

6.2.4 Only one Application

The Applicant shall submit only one Application and such Application shall be from a limited liability company. If any Applicant submits or participates in more than one Application, all such Applications shall be disqualified and rejected.

6.2.5 Application validity

Applications shall remain valid for the period specified in section 6.3 Application Data Sheet after the Application submission deadline prescribed by the Authority. An Application that is valid for a shorter period shall be rejected by the Authority as non-responsive. During this Application validity period, an Applicants shall maintain its original Application without any change.

6.2.6 Extension of validity period

The Authority will make its best effort to complete the application procedure within the Application's validity period. However, should the need arise, the Authority may request, in writing, all Applicants who submitted Applications prior to the submission deadline to extend the Application validity.

If an Applicant agrees to extend the validity of its Application, it shall be done without any change in the original Application.

An Applicant has the right to refuse to extend the validity of its Application in which case such Application will not be further evaluated and rejected.

6.2.7 Submission, sealing, and marking of Applications

Applicants shall submit their Applications in hard copies to the Authority's office located at the address specified in section 6.3 Application Data Sheet. A total of six (6) sets of documents must be submitted, one (1) original document, clearly marked "ORIGINAL" and five (5) copies, each clearly marked "COPY". It is the Applicants' responsibility to ensure that all sets of documents are identical. In the event of any

variation, the content of the "ORIGINAL" document will be regarded as that Applicant's official submission.

Applications shall be typed or written in permanent ink and shall be signed by a person duly authorized to sign on behalf of the Applicant, verified with a company stamp in the presence of a named witness. All pages must also be initialled by the authorized person. This authorization shall consist of a power of attorney as set out in Appendix E: Power of Attorney and shall be attached to the Application.

Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialled by the person signing the Application.

Applications shall be submitted in hard copy as specified in section 6.3 Application Data Sheet. The hard copies shall be accompanied by a soft copy in "pdf format" on a USB pen drive. In case of any discrepancies between the hard and soft copy, the hard copy will prevail.

Applicants submitting Applications shall follow the procedures as described in section 6.3 Application Data Sheet.

6.2.8 The close of Application submission

The deadline for Application submission is indicated in section 6.3 Application Data Sheet.

6.2.9 Confidentiality

Information relating to the examination, evaluation, comparison, and pre-qualification of Applications, and recommendation of the award, shall not be disclosed to Applicants or any other person(s) not officially concerned with such process until publication of the licence assignment.

Any effort by an Applicant or any person to influence the Authority or members of its evaluation committee in the examination, evaluation, comparison, and pre-qualification of the Applications or spectrum award decisions, shall result in the rejection of its Application.

6.2.10 Late Applications

The Authority shall not consider any Application that arrives after the deadline for Application submission. The Application submission must be placed into the application box on or before the closing time indicated in section 6.3 Application Data Sheet. At the time for the close of Applications the application box will be closed.

Late submissions will be automatically rejected by an officer appointed by the Authority. Applicants are therefore urged to submit their proposals in hard copies at least two (2) hours prior to the close of submission time.

6.2.11 Clarification

Persons requiring clarification are required to submit their queries within the designated timeline via the email address specified in section 6.3 Application Data Sheet.

The Authority will not be held liable for Applications that are not submitted on time.

6.2.12 Taxes

The Awardee is responsible for meeting all tax liabilities arising out of the award of spectrum unless stated otherwise in section 6.3 Application Data Sheet.

The Deposit shall exclude taxes and duties in Jamaica in accordance with the instructions in section 6.3 Application Data Sheet.

6.2.13 Currency of Application and payment

The currency of the Deposit and the outstanding balance for the Spectrum Licence Fee shall be United States Dollars.

6.2.14 Corrections of errors

No corrections by the Applicant of the submitted Application shall be permitted. In the event of a conflict between words and figures, the words shall prevail. However, the Authority may request clarifications, only concerning the submitted Pre-qualification documentation during the Pre-qualification Stage.

6.2.15 Collusion and anti-competitive behaviour

The Active Period begins on the day of the publication of this Information Memorandum and terminates on the day the Spectrum Licence is assigned and the Authority announces the holder(s) of the Spectrum Licence(s) by public notice.

6.2.16 Deposit

The required Deposit can be paid in cash into the nominated bank account set out in Appendix F: Nominated Bank Account – Wire Instructions, and/or by way of an irrevocable letter of undertaking issued by a financial institution licensed pursuant to the Banking Services Act, 2014 as set out in Appendix B: Irrevocable Letter of Undertaking.

The amount of the required Deposit is set out in section 6.3 Application Data Sheet.

Interpretation

2. In this Licence, unless the context otherwise requires:

"Authority" means the Spectrum Management Authority.

"Convention" means the International Telecommunication Convention of Nairobi, 1982 and the General and Administrative Regulations thereof and includes any Convention and any Regulations which may from time to time be in force in substitution thereof or amendment thereto and to which the Government of Jamaica is a party.

"International Radio Regulations" means the Radio Regulations annexed to the Convention and includes any Regulation made in the amendment, in addition to or substitution for the said Radio Regulations.

"Licence" means the **Spectrum** (Successful Applicant) Licence 2024.

"Licensed Spectrum" means the spectrum set forth in the Schedule.

"Licensee" means Successful Applicant and any successors or assigns of that Company.

"Minister" means the Minister who, for the time being, has principal responsibility for the regulation of telecommunications and includes any person or body to whom the Minister has delegated his or her powers in relation to Spectrum Management.

"Telecommunications Act" means the Telecommunications Act of 2000, as may be amended from time to time, and a reference to the

Telecommunications Act includes each Regulation, Rule or other Instrument made pursuant to that Act.

Except where specifically provided for in this Licence, expressions in this Licence have the same meanings as under the Telecommunications Act.

Grant of Licence

- 3.1 Subject to the Terms and Conditions set out herein, the Licensee is hereby licensed to use those portions of the electromagnetic spectrum as set forth in the Schedule in the most efficient manner that is technically and economically feasible for the term of this Licence and subject to the provisions of the Telecommunications Act and this Licence.
- 3.2 The Licensee is to utilise the assigned spectrum for the deployment of commercial voice and mobile broadband services as follows:
 - At least 50% population coverage in the entire country within 12 months from the start date of the validity of the Licence.
 - At least 95% population coverage in the entire country within 24 months from the start date of the validity of the Licence.
- 3.3 In addition, the Licensee is to utilise the assigned spectrum for the deployment of commercial voice and mobile broadband services within the areas specified herein at Appendix A titled Unserved and Underserved Communities ('Supplied List"). Coverage to these areas must be rolled out at the same rate as coverage for the general population, namely:
 - At least 50% of the population in the Communities on the Supplied List within 12 months from the start of the validity of the Licence.

- At least 95% of the population in the Communities on the Supplied List within 24 months from the start of the validity of the Licence.
- 3.4 For the purposes of clause 3.2 and 3.3, the served population should receive the mobile services from the Licensee at a signal strength of 105 dBm or higher.

Data Rate

 The Licensee is to provide a minimum download data rate of five (5) Mbps under peak traffic conditions in any of the coverage areas as specified above in clause 3.2 and 3.3.

Non-Observance

- If the Licensee fails to fulfil the deployment conditions specified in clause 3.2 and 3.3, the Authority shall:
 - Impose liquidated damages of J\$2,000,000.00 when it confirms that the conditions have not been met.
 - Impose a further sum of J\$3,000,000.00 every subsequent month where the conditions are not met.
 - If the deployment conditions still have not been met six (6) months after the first charge, the Licence may be suspended or revoked in accordance with Section 23A of the Telecommunications Act.

Duration and Renewal of Licence

- 6.1 This Licence shall be renewable subject to the Licensee's record of compliance with the terms and conditions of the spectrum licence, and the provisions of the Act or any regulations made thereto.
- 6.2 This Licence has a term of fifteen (15) years, subject to compliance with the terms and conditions contained herein.

Scope of Rights in Spectrum

7. This Licence does not grant to the Licensee any property right in the electro-magnetic spectrum or right to use the spectrum except in accordance with the terms of this Licence.

Harmful Interference

8. Pursuant to Section 63A(1) of the Telecommunications Act, the Licensee shall take such steps as the Minister may, by notice in writing to the Licensee, reasonably require to ensure that, in the exercise of any rights in relation to the Licensed Spectrum, the activities of the Licensee do not cause harmful interference to the lawful operation, in relation to the spectrum, of any other authorised user of the spectrum.

Frequencies

- 9.1 Authorisation of the use of any frequency by the Licensee may be withdrawn by the Minister after reasonable notice to the Licensee if such frequency remains unused by the Licensee for twelve (12) consecutive months. However, upon the written request of the Licensee, the Minister may, in consultation with the Authority, grant an extension of six (6) months or such longer period as the Minister may deem necessary to ensure efficient utilisation of the spectrum.
- 9.2 Changes in location of licensed facilities, emission, power or use of aerial systems relating to the use of the Licensed Spectrum shall only be made by the Licensee in accordance with the approval of the Minister except that:
- i) Changes that do not increase the likelihood of harmful interference are permitted; and
- ii) A suitable alternative frequency may be assigned at any time by the Minister

for transmission at any point to replace and release any frequency set forth in the attached schedule hereto, in order to ensure a more efficient use of the frequency spectrum. Notwithstanding the foregoing, the Minister will endeavour to provide reasonable notice and shall consult with the Licensee where changes to the assignment are to be undertaken.

Call Signs

- 10. Whenever rendered necessary in order to secure compliance with the International Radio Regulations, or identify the source of harmful interference with any other facility lawfully operated, the Minister may:
- By notice in writing to the Licensee, assign call signs to all of the stations operated by the Licensee; and
- ii) In the same or another notice as foresaid, direct that the call signs so assigned shall be announced in such manner as may be authorised in such notice.

<u>Fees</u>

- 11.1 The Licensee shall be required to pay Spectrum Licence Fees in relation to all allocations of Spectrum, and Spectrum Regulatory Fees pursuant to Section 26 of the Telecommunications Act to cover the reasonable operating costs of the Authority.
- 11.2 The Licensee shall be required to pay Spectrum Licence Fees as follows: (a) an upfront payment that shall be payable prior to the issuance of the Licence and (b) further equal payments each due and payable in 2025, 2026, 2027, 2028, 2029, 2030, 2031, 2032, 2033 and 2034.
- 11.3 The Licensee shall be required to pay annual Spectrum Regulatory Fees, as invoiced, from the start of the validity of the Licence.

11.4 The Minister may review the fees pursuant to Section 23(7) of the Telecommunications Act.

Modification of Licence

12. This Licence may be modified, in writing, at any time upon mutual agreement between the Minister and the Licensee after consultation with the Authority.

Reporting requirements

13. The Licensee shall provide bi-monthly reports on the progress of the deployment of the network and services until the network and services are fully deployed as indicated in clause 3.2 and 3.3.

Revocation or Suspension of Licence

- 14. The Licence may be revoked or suspended:
- i) In accordance with Section 23A of the Telecommunications Act;
- ii) If the Licensee fails to use the spectrum efficiently;
- iii) If the Licensee fails to achieve the rollout requirements as included in clause 3.2 and 3.3, within six (6) months after the prescribed timeline; or
- iv) If the Licensee's Domestic Mobile Carrier and/or Domestic Mobile Service Provider Licence is suspended or revoked pursuant to the Telecommunications Act.

In the event this Licence is revoked pursuant to Section 23A(6)(h) of the Telecommunications Act, the Licensee shall be entitled to receive a pro-rata refund of the Spectrum Licence Fees. Such payment will not be subject to inflationary or exchange rate adjustments.

Assignment or Transfer of Licence

15. This Licence, or any rights thereunder, shall not be assigned or transferred, nor

shall there be a transfer of control of the Licensee's operations (whether directly or indirectly) without the prior written approval of the Minister.

General

- 16. The Licensee shall ensure at all times that:
- The Licensee complies with all obligations under the Telecommunications Act and all other laws of Jamaica;
- ii) No legal impediment exists which would disqualify the Licensee from continuing to hold the Licence and that the Licensee satisfies all other legal requirements to hold the Licence;
- iii) The Licensee has the technical qualifications to fully perform the obligations attaching to the Licence; and the Licensee satisfies any and all financial requirements, as imposed pursuant to the Act;
- iv) The Licensee adheres to all the directions of the Authority; and
- v) The Licensee is not directly or indirectly connected to or in any way affiliated with another holder of a Spectrum Licence without the prior approval of the Minister.
- 17. The Licensee will be required to permit persons authorized by the Authority, that is, staff or authorized agents, to have access to and to examine and test the radio equipment specified in the Spectrum Licence at all reasonable times. The purpose would be to ensure that the radio equipment is being used in accordance with the conditions of the Spectrum Licence.
- 18. The Authority shall require the radio equipment in use or any part of it to be modified, restricted, or

- temporarily or permanently closed down if the Licensee has breached the terms of its Licence, and/or, the use of the radio equipment is or may be causing or contributing to harmful interference to the operation of other licensed or authorized spectrum users.
- 19. Any notice or other document required or authorised to be served upon the Licensee under the Telecommunications Act or this Licence, may be served by registered post to the Licensee's registered office or by dispatching it to the Licensee's registered office by courier.
- 20. This Licence and the terms and conditions hereof, shall constitute the entire grant of the Licence and supersede any prior Licences, permits or undertakings in relation to the Licenced Spectrum.
- 21. If a provision of or part to this Licence is deemed unlawful or unconstitutional, the remainder of this Licence shall remain valid and enforceable.
- 22. To the extent that this Licence refers to specific parts or sections of the Telecommunications Act, such parts or sections shall be deemed renumbered in this Licence according to any such renumbering of those parts or sections in the Telecommunications Act, as a result of the amendment of that Act.
