The Spectrum Management Authority (SMA) Limited is a Statutory Body under the Ministry of Science, Energy, Telecommunications and Transport (MSETT) has made budgetary allocation toward the improvement of its spectrum management capabilities and intends to apply part of this budget to the upgrade of a Mast and Covert Monitoring System.

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Government of Jamaica (GoJ), Public Procurement Act, 2015 and the Public Procurement Regulations, 2018, and is open to all Eligible and Qualified bidders as defined in the Policies.

- Provides Real-time monitoring
- Monitoring up to 8Ghz
- Direction Finding (6Ghz minimum)
- Compatible with Spectrum Monitoring Software (SCORPIO™, R&S Argus)
- Antenna Polarization: Vertical and Horizontal
- IF bandwidth 40Mhz minimum
- DF antenna is active/passive & controlled by Spectrum Monitoring Software

### Eligibility for Bid Submission

To establish eligibility all Bidders must comply with the following criteria at the time of bid submission.

- a. Signed copy of Power of Attorney
- b. Signed copy of Bid Submission Form along with all other forms in the listed section; **See ITB 14.1 in Bidding Documents**

A complete set of Bidding Documents in English will be available for download as of **December 04, 2024** on the GoJ Electronic Procurement website [www.gojep.gov.jm](http://www.gojep.gov.jm). Registration instructions are available on the website. Mandatory registration is required for vendors to participate.

Failure to obtain the bidding documents from the SMA via the GoJ Electronic Procurement website will result in the Bidder's ineligibility to participate in the procurement process.

### Deadline for Submission of Bids

Bids must be submitted online via [www.gojep.gov.jm](http://www.gojep.gov.jm) no later than **January 6, 2025 at 3:00 pm**, Jamaica Time (UTC 5).

The system will automatically reject a late bid.

### Bid Opening

Online bid opening takes place on **January 6, 2025 at 3:15 p.m. Jamaica Time (UTC 5)**.

An online bid opening report will be sent to all Bidders that submitted a proposal.

The GoJ is not obliged to accept the lowest or any bid and reserves the right to cancel the bid process at any time before the award of a contract without incurring any liability to any of the Bidders.
