The Spectrum Management Authority (SMA) Limited is an Agency of the Ministry of Science, Energy, Telecommunications and Transport (MSETT) has made budgetary allocation toward the improvement of its spectrum management capabilities and intends to apply part of this budget to the procurement of a Cell On Wheels (Transportable Radio Monitoring & Directional Finding System).

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Government of Jamaica (GoJ), Public Procurement Act, 2015 and the Public Procurement Regulations, 2018, and is open to all Eligible and Qualified bidders as defined in the Policies.

#### **Product Specification:**

General:	Shelter integrated atop a 15,000lb capacity Gross Vehicle Weight Rating (GVWR), multi-terrain drawbar trailer with all-wheel electric brakes that incorporates a heavy-duty telescopic outrigger stabilizing system configured to support shelter
Mast:	Elevation of minimum 20 feet; Minimum Load Capacity: 40 kg
Electrical:	Interior: 2-bulb L.E.D. fixture, 120VAC; Exterior: Exterior grade LED lights with photocell
Generator:	7kW Diesel Generator minimum IF bandwidth 40Mhz minimum
Shelter:	Approximate Outside Dimensions: 8 feet long x 8 feet wide x 8 feet tall (height includes 6 inches skid) - Minimum Approximate Inside Dimensions: 7 feet 4 inches long x 7 feet 4 inches wide x 6 feet 9 inches tall - Minimum
Air Condition	One (1) 2-ton cooling (24,000 BTU)

### Deadline for Submission of Bids

Bids must be submitted online via www.gojep.gov.jm no later than January 27, 2025 at 3:00 pm, Jamaica Time (UTC 5). The system will automatically reject a late bid.

#### **Bid Opening**

Online bid opening takes place on January 27, 2025 at 3:15 p.m. Jamaica Time (UTC 5). An online bid opening report will be sent to all Bidders that submitted a proposal.

The GoJ is not obliged to accept the lowest or any bid and reserves the right to cancel the bid process at any time before the award of a contract without incurring any liability to any of the Bidders.
